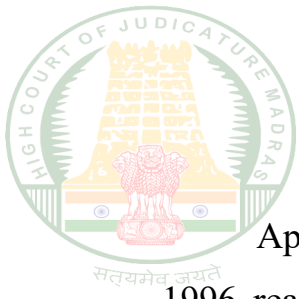

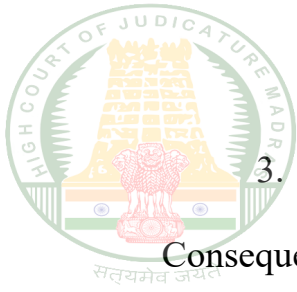

This Miscellaneous Petition has been filed to condone the delay of 236 days in filing Arbitration Appeal (CAD) SR.No.171637 of 2025 on the file of this Court.

2. The present appeal is arising out of the order passed by the learned Single Judge under Section 34 of the Arbitration and Conciliation Act, whereas the limitation for filing appeal under Section 37 of the Arbitration and Conciliation Act is, 30 days. Further, the reason stated in the affidavit filed in support of this petition is not satisfied. Therefore, this Court is not inclined to condone the delay.



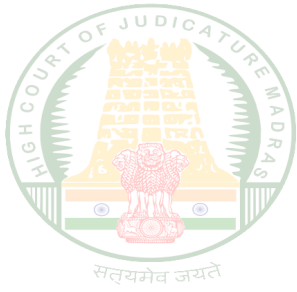
3. Accordingly, this Civil Miscellaneous Petition is dismissed.
