THIS WP IS FILED UNDER ARTICLES 226 AND 227 OF THE CONSTITUTION OF INDIA PRAYING TO QUASH/SET ASIDE THE I.A.NO.79/2019 UNDER RULE 11 OF THE NCLT RULES, 2016 DATED 14TH MARCH 2019 IN C.P.NO.464/BB/2018 PASSED BY THE NATIONAL COMPANY LAW TRIBUNAL, BENGALURU AT ANENXURE - E AND ETC.,

THIS PETITION, COMING ON FOR PRELIMINARY HEARING IN 'B' GROUP, THIS DAY, ORDER WAS MADE THEREIN AS UNDER:

ORAL ORDER

1. Petitioners are seeking the following reliefs:

"Wherefore, the petitioners pray that this Hon'ble Court may be pleased to -

(i) Issue a writ in the nature of certiorari or any other writ, order or direction, quashing/setting aside the IA No.79/2019 under Rule 11 of the NCLT Rules, 2016 dated 14th March,2019 in CP No.464/BB/2018 passed by the National Company Law Tribunal, Bengaluru at Annexure-E;

(ii) Allow the application IA No.79/2019 under Rule 11 of the NCLT Rules, 2015 as prayed for;

(iii) Direct the respondents to pay costs of the above petition, and grant such other and further reliefs, as are just."

2. Learned counsel for respondents submits that there is an appeal provision provided under Section 61 of the Companies Act, before the National Company Law Appellate Tribunal.

3. Learned counsel for the petitioners seeks liberty to avail such remedy. He seeks for a direction to consider the time consumed in prosecuting the present petition, for the purpose of condonation of delay.

4. Since alternative statutory remedy is provided, petitioners are at liberty to avail the same if so advised. If such an appeal is filed, time consumed in prosecuting the present petition may be considered for the purpose of condonation of delay, subject to all just exceptions.

5. With the above observations, the writ petition is **disposed of.**
