ORDER
HYBRID MODE

13.08.2026: This appeal is filed against an impugned order dated 24.07.2026 passed by the adjudicating authority in I.A. No.3015/2026 in C.P. (IB) No.96/2024.

2. The I.A. No. 3015/2026 was filed on 15.07.2026 by the appellant herein under Section 60(5) of the Insolvency & Bankruptcy Code, 2016 (for short the “**IBC**”) seeking direction to stay the implementation of the email dated 14.07.2026 sent by the Resolution Professional (“**RP**”) viz. respondent No. 1 to the applicant regarding exclusion of the applicant’s proposed resolution plan for the purpose of consideration and voting and to set aside the same.

3. During the course of arguments both the learned senior counsel agreed that the appeal may be disposed in terms of the following:-

- i) Since the impugned order is an interim order hence the Ld. NCLT be requested to finally decide IA No.3015/2026 expeditiously and it be decided on its own merits and in accordance with law without being influenced by any observations made in the impugned order.
- ii) All the parties shall cooperate.
- iii) The voting line shall remain open for the period of 10 days from today and the CoC shall proceed to declare the voting results thereafter.

4, In view of the above, we dispose of this appeal by requesting the Ld. NCLT to hear and decide IA No.3015/2026 within 7 days from today i.e. prior to 19th August, 2026. In case, the application is not so decided prior to the 10 days as above, parties shall be at liberty to seek appropriate remedy under the law. This order is without prejudice to rights and contentions of all the parties.

5.The appeal stands disposed off.

6. Pending applications are also disposed off.
