O R D E R

1. We heard Ms. Meenakshi Arora, the learned senior counsel appearing for the appellant, Mr. Navin Pahwa, the learned senior counsel appearing for the respondent no.1 (shareholder), Mr. Rajesh Kumar Gautam, the learned senior counsel appearing for the Indian Bank. We also heard Mr. Krishnan Venugopal, the learned senior counsel appearing for the respondent no.2 and in the last, we also heard Mr. C.A. Sundaram, the learned senior counsel appearing for a party, namely, Brightlane Infraspaces Pvt. Ltd., who has some interest in this litigation.

2. In the appeals before us, the following reliefs have been prayed for:-

"A. Admit and the Allow the instant Civil Appeal against the impugned judgment and interim orders dated 17.06.2026 & 29.06.2026 in I.A. No.4230 of 2026 in Company Appeal (AT) No.210 of 2026 passed by the Hon'ble National Company Law Appellate Tribunal Principal Bench, New Delhi in the interest of justice; and

B. Permit Respondent No. 2 Company to raise capital by way of a Rights Issue at par offered to all its existing shareholders in proportion to their shareholding, in terms of the proposal made before the Appellate Tribunal, the Appellant and Respondent No. 5 being ready and willing to contribute the entire amount including to the extent of any shares remaining unsubscribed;

C. Pass any other order and/or directions, as this Hon'ble Court may be fit and proper under the facts and

circumstances of the present case”

3. Having regard to the nature of the submissions canvassed before us, it is difficult for us to adjudicate the disputed question of fact.

4. The matter is coming up before the NCLAT Principal Bench, New Delhi on 23.07.2026. It shall be open for all the concerned to raise all legal contentions available to them before the NCLAT on 23.07.2026.

5. It shall also be open for the client of Mr. Sundaram to make his submissions before the NCLAT, if at all, he is a party before the NCLAT. If the client of Mr. Sundaram is not a party, he may apply and it is for the NCLAT to decide whether the client of Mr. Sundaram is a proper or a necessary party in the proceedings.

6. We make an earnest request to the NCLAT to see that on 23.07.2026 the matter is heard for sure. We make this request to the NCLAT because we are informed that NCLT has reserved the order insofar Section 7 IBC application is concerned.

7. With the aforesaid, these appeals stand disposed of.

8. Pending application(s), if any, shall also stand disposed of.
