UPON hearing the counsel the Court made the following
O R D E R

1. Learned Senior Counsel appearing for the first respondent has, at the outset, fairly offered to pay the subject amount of Rs. 44 lakhs to the petitioner within two weeks. The said offer is acceptable to the learned counsel appearing for the petitioner. The issue regarding the deposit of the said amount and the consequential entitlement of the other family members of the petitioner is *sub judice* before National Company Law Tribunal, Indore Bench (in short, 'NCLT').
2. We direct the NCLT to decide the said controversy expeditiously and preferably within three months. Needless to observe that all the contentions of the parties are left open to be raised before the NCLT.
3. In view of the subsequent developments, the directions contained in our order dated 01.08.2025, directing the Reserve Bank of India to conduct a financial audit of the accounts of the first respondent, have becomes infructuous. The said directions are, accordingly, recalled.
4. The Special Leave Petition is disposed of in the above terms with a direction that the parties shall abide by the statements made before this Court.
5. All pending applications, including application for intervention/impleadment, stand disposed of.
